

# TECHNODOLLY REPEATABLE CAMERA CRANE — CONDITIONS OF HIRE (REVISED)

These Conditions of Hire apply to all TechnoDolly bookings with Sandstorm Media Limited and supersede any previous agreements between the Hirer and Sandstorm. They cover TechnoDolly equipment hire, trained operator hire, and any additional crew or equipment supplied by Sandstorm. ## Definitions

**"You/Hirer"**: the person, company, or production responsible for the hire.

**"We/Sandstorm/Sandstorm Media Ltd"**: Sandstorm Media Limited (Company No. 05748173).

---

## 1) General Terms

1.1 Our goal is to help you deliver a smooth, productive, and enjoyable shoot. Please note the TechnoDolly is rare, highly specialised, and uniquely capable.

1.2 A standard shooting day is **10 hours plus 1 hour for lunch, or 10 hours continuous**, scheduled between **07:00–19:00 (Mon–Fri)**.

1.3 Crew hours, including weekend and night work, follow **APA/BECTU** guidelines as a standard.

1.4 By confirming your booking, you acknowledge that the TechnoDolly is suitable for your production's needs.

1.5 The Hirer must provide and maintain adequate **insurance** for all hired equipment and activity. Proof of cover is required prior to shooting in our facilities or taking our equipment and crew on hire. The TechnoDolly has an insurance value of **£600,000 per crane for the TechnoDolly 15 variant and £1,000,000 for the TechnoDolly 25 system** (plus ancillary equipment).

1.6 When equipment is left on a stage or location outside active shooting hours, the Hirer is responsible for **security and insurance** throughout. Sandstorm photographs the equipment

at end of day; time - and date-stamped images are available on request.

1.7 **Written confirmation** (a Purchase Order and/or full advance payment, as applicable) is required to secure a booking. Verbal confirmations are not accepted.

1.8 Sandstorm holds public and employers' liability insurance; however, for all productions **outside Sandstorm's own studio**, responsibility for production activity and associated risks rests with the Hirer.

1.9 Provisional holds ("pencils") cannot be guaranteed. If a confirmed booking supersedes a pencil, we will notify you before accepting the confirmed booking.

1.10 Please inform us in advance if your shoot involves any activity that may require additional precautions, facilities, or specialist services, including (but not limited to): high sound levels/music playback, firearms/blank fire, heat/humidity, dust/debris, set builds, working at height, nudity, pyrotechnics, flammables, smoke, liquids, stunts, animals, or children.

## 2) Payment Terms

2.1 Clients without a robust trading history directly with Sandstorm must pay **100% of quoted fees in advance** to confirm the booking.

2.2 **Overtime** applies after the 10th hour of the shooting day and is charged **pro-rata per hour**.

2.3 Weekend utilisation is charged at **1.5×** the standard day rate; **night work** is charged at **2×** the standard day rate.

2.4 UK VAT is charged at the prevailing rate (**20%** for UK-registered non-charitable clients).

2.5 For clients without a trading history, **full prepayment** is required for any services or facilities.

2.6 On completion of the shoot, we will invoice for **overtime, additional crew, extras, and consumables**. Payment terms will be as stated on the invoice.

## 3) TechnoDolly Hire Requirements & Precautions

3.1 The TechnoDolly is unique, and our rigs and operators are among the very few available in the UK.

3.2 Except where caused by Sandstorm's negligence or wilful misconduct, Sandstorm is **not liable** for delays arising from the TechnoDolly becoming temporarily inoperable. We will always work promptly to remedy issues and return to a reasonable schedule. Any claims must be supported by evidence demonstrating negligence by Sandstorm's operators.

3.3 The TechnoDolly's insurance value is **£600,000 and £1,000,000 respectively**. Proof of adequate cover (including **transit cover**) is required prior to hire.

- The TechnoDolly is transported in custom, fully road-legal vehicles.

3.4 **Power requirements:** clean **63A single-phase or 32A three-phase** supply with high-quality earthing, delivering full range and speed. Power is typically drawn as **3 × 16A (≈3 kW per channel) for the crane plus 1 × 16A for the desk**, all from the **same clean, earthed circuit. Both desk and crane must share the same earth and circuit.**

3.5 If the stage or location is hot or humid, the Hirer must provide **direct portable air-conditioning** to keep the rig within optimal operating temperatures.

3.6 The TechnoDolly is supplied with a **SuperTechno S-head** and **60 ft of track** (10 ft sections) as quoted. It **must run on its own track**. Third-party heads may be physically fitted but **cannot repeat** TechnoDolly moves and are outside Sandstorm technicians' responsibility.

3.7 The TechnoDolly is hired with a **minimum of two Sandstorm technicians**. Typically, one is the technical operator and one is the assistant. A separate "head tech + crane tech" is not required.

3.8 Operation can be **hybrid**: your grips may operate selected functions, or Sandstorm technicians can operate the crane and head entirely – depending on shot requirements and at production's discretion.

3.9 When using third-party/freelance grips or technicians, we **strongly recommend at least a test day** before principal photography due to the steep learning curve. If tests are omitted, any delays caused by on-the-day training are the production's responsibility.

3.10 For simplicity and cost-efficiency, consider hiring the TechnoDolly **within Sandstorm's own studios** as part of a production facilities package.

3.11 Sandstorm warrants that: (i) the equipment is free from defects and in good working order for its intended purpose; (ii) Sandstorm complies with all applicable laws, regulations, and manufacturers' specifications; and (iii) to Sandstorm's

knowledge, the equipment is free from latent defects or unlawful conditions.

## 4) Insurance & Safety

4.1 While working with Sandstorm, the Hirer is responsible for **insurance against theft, loss, or damage** to equipment while in the Hirer's care, custody, and control (including any third parties engaged by the Hirer). Sandstorm accepts no liability unless negligence or wilful misconduct by Sandstorm's operators is proven.

4.2 The Hirer is responsible for **personal injury cover** for their cast and crew and for liability to third parties.

4.3 The Hirer is responsible for on-set **health & safety**, including maintaining safe working distances from the TechnoDolly and associated plant.

4.4 The Hirer must complete a **hazard/risk assessment** and provide suitable **RAMS** prior to the shoot. Sandstorm's standard TechnoDolly RAMS are available on request.

4.5 The studio/location must have a **qualified first-aider on stage** at all times.

## 5) Cancellations & Date Changes

5.1 Due to global demand and limited availability of TechnoDolly systems and operators, we cannot guarantee pencils. Bookings are confirmed **only** on receipt of written confirmation and/or required payment. We operate a strict **first-come, first-served** policy for confirmed bookings.

- We recognise this differs from common UK practice and can be challenging for productions. We will always do our best to accommodate reasonable date changes.
- Where a production date moves through no fault of the Hirer, we will endeavour to amend the booking to new dates **without additional charges**, subject to availability.
- We cannot guarantee availability on revised dates and any reimbursement remains at Sandstorm's **sole discretion**.

5.2 Once confirmed, any modification may incur cancellation fees as follows:

- **Within 7 calendar days of the first booked day: 100% of all fees** become payable.
- **Within 30 calendar days: 100% of equipment fees** (TechnoDolly and ancillary equipment) as quoted become payable.

- **From the moment of booking confirmation (regardless of date): 100% of TechnoDolly hire fees** become payable.

5.3 We will always seek to **refund where possible** if no direct costs have been incurred by Sandstorm and/or circumstances are demonstrably beyond the Hirer's control.

5.4 Any change of dates after confirmation remains **subject to availability** of equipment and crew and at Sandstorm's discretion.

**Important:** It is the Hirer's responsibility to ensure the production is **adequately assessed and insured**. Failure to provide sufficient insurance or RAMS may result in cancellation of the booking.
